19th INTER KODAVA SANGHA SHUTTLE BADMINTON TOURNAMENT 2025

- 1. The above tournament will be conducted jointly by Kodava Samaja Bengaluru and Kodava Samaja Sports and Recreation Club.
- 2. The Tournament will be played at the newly constructed Shuttle Badminton Courts at Sree Cauvery School, Indiranagar, Bangalore 560 038.
- 3. The aim and objective of the tournament is to foster Kodava Spirit, Sportsmanship, Cooperation, Co-ordination, Oneness, and a sense of belonging amongst Kodavas.
- 4. The Tournament is open to all the Kodava Sanghas registered with Kodava Samaja, Vasanthanagar, Bangalore, functioning in the agglomerated limits of Bangalore, as per our byelaw.
- 5. Each Sangha is permitted to file only one entry in each age group i.e. (Men/Women/Children/Mixed Doubles).
- 6. The participating members shall be domiciliary of their respective Sangha, he/she represents.
- 7. Participants should be a Life member of the Kodava Samaja, Bengaluru, and the Sangha representatives must submit the duly completed entry form, including the player or participants Name, Date of birth & KSB Membership No.. Entries without this information will not be accepted.
- 8. The participants who have already become members of Kodava Samaja, but after marriage do not enjoy the status of membership are not allowed to participate.
- 9. If the participant member is below 18 years, either their parents shall be the Life members of Kodava Samaja Bengaluru.
- 10. Any change in the players residing address can be updated at Kodava Samaja, Bengaluru office in person on or before 7th July 2025 (Monday) 5.00 pm by producing the necessary documents as required. (No changes will be entertained post the mentioned date).
- 11. If there are any replacements to the players listed under the respective age categories, the concerned Sangha President or Secretary must inform Kodava Samaja, Bengaluru either via email or submitting a letter in person by 14th July 2025 (Monday) before 5 PM. Please note that no new player additions to any category will be permitted.
- 12. The entry form must be duly signed or emailed by the respective Sangha President or Secretary to Kodava Samaja Bengaluru. For further details, please refer to Sl No. 3 of the New Policy for competition at Kodava Samaja Bengaluru.
- 13. As per Clause 1(f) of the New Policy for Competitions at Kodava Samaja, Bengaluru, professional players or participants below the age of 35 as of the match start date are not eligible to participate. Additionally, players who have won at the

State level-regardless of category or have represented in National-level tournaments are barred from participating for a period of five years from the date of their State-level victory or National-level representation, up to the age of 35. Participation will be permitted only after a five-year period of non-representation or non-victory at the State or National level, as outlined above.

- 14. The Tournament shall be played as per the existing rules of BAI (Badminton Association of India). Nylon Shuttle Cocks (MAVIS 350) will be used for the Tournament.
- 15. The Tournament Committee reserves the right to make any changes in the date and timings of the tournament.
- 16. The Tournament will follow a Knock Out format. Matches upto the Semi-finals, will consist of a single game played to 30 points. The Semi-finals & Finals will be played as best of three sets, with each set played to 21 points.
- 17. Any event to be conducted must have a minimum of 4 entries for the singles and 4 teams for the doubles, if less than the above, such entries/ teams will be cancelled.
- 18. All the players must play in their respective age group only.
- 19. All players must report at least one hour before their scheduled matches.
- 20. The respective Sangha Presidents / Secretary are responsible for maintaining discipline among their players during the tournament.
- 21. If Sangha's President / Secretary desire to lodge protest against the decisions of umpires / technical official or any other matter (Such as misuse of Rule 7, 8, and 18), may do so within 30 minutes after the completion of the match by giving it in writing to the Tournament Committee comprising of Chairman, Convenor with a protest fee of Rs.1,000/- (Rupees one thousand only). If the protest is upheld then the protest fee will be returned to the concerned Sanghas, otherwise the amount stands forfeited.
- 22. If the Sangha's President / Secretary wish to appeal against the decision of the tournament committee, they can appeal to the Appeal Committee comprising of Office Bearers of Kodava Samaja Bengaluru by paying an additional appeal fee of Rs.2,000/-(Rupees Two Thousand Only) within one hour after the protest decision is conveyed to them. If the protest is upheld then the protest fee will be returned to the concerned Sanghas, otherwise the amount stands forfeited.
- 23. Decision of the Appeal Committee shall be final, in case where rules and regulations are not covered here.
- 24. All the players are requested to mandatorily carry the ID Proof (Aadhar/PAN/Driving License/SSLC Marks Card) for age verification on demand.
- 25. Players are requested to be in sports attire & very strictly only Non-Marking Badminton shoes should be used.

New Policy for Competitions at Kodava Samaja Bengaluru

The below policy holds good for all Kodava Samaja Bengaluru competitions – both sports and cultural

1. Players/participants Eligibility

- a) Players/participants Male or Female must be living in the Sangha area.
- b) A Players/participants must have a house (Owned or Rented) in which he/she is residing. That is to say he/she should be working from that home and comes back to reside there after each day's work
- c) There may be a case where the spouse and children are living at that address due to educational purposes of the children while the member / players/participants may be shuttling between Kodagu and Bangalore or other places of work. Such players/participants/members are eligible.
- d) Unmarried children of members (such members who are currently residing in the sangha area) may play/participate even if they are

- studying/ working elsewhere. This is applicable for unmarried children who are studying/working outside Bengaluru.
- e) Persons who have a house in a particular Sangha jurisdiction area but have permanently moved to Kodagu or elsewhere by giving his/her home on rent or even keeping it locked are not eligible.
- f) Professional players/participants under 35 years of age are not eligible even if residing in the area.
- g) Players/participants residing in border arears between Sanghas and enjoying dual membership will have to get a NOC from the President of the Sangha they are not representing in. The choice of which Sangha to play for in such situations rests with the players/participants.
- h) New KSB members must have resided in the given address for at least six months before participating, however address changes for existing members can be made before the sports cutoff date.
- a) Guest Players/participants. No guest players/participants are allowed.

2. Penalty for Violation

- a) This policy can only succeed if all Sanghas cooperate and if they truthfully field teams meeting all the criteria. The Team lists sent by the Sanghas will be scrutinized and verified with the help from Sanghas by the Sports Committee.
- b) After verification the team list will be made public for all the Sanghas to make note of. Any objections should be raised within a stipulated time after which the lists will be considered as final, and no changes will be allowed. During the course of the matches even if some players/participants are injured, they will have to make replacement from within the original list provided before submission date.
- c) After all the above measures, if some falsification is still found, such teams will be disqualified from the tournament and will not be allowed to field a team in any sport for one year.



3. Undertaking by Sangha Presidents. The submitted players/participants list has to be verified, and the respective Sangha President has to sign off on the correctness of the lists being submitted by the respective Sangha.
